

Pre/Post Vehicle Inspections

What is it?

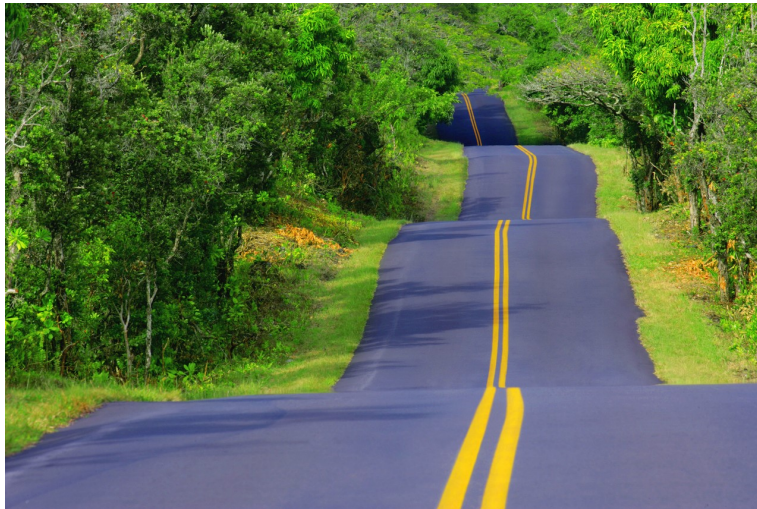
A Pre or Post Trip Vehicle inspection is walk around visual and hands on inspection of a work vehicle conducted before any employee takes a work vehicle out on the road and when the vehicle is returned to service at end of trip, or shift.

Who is responsible for doing the Pre and post Trip inspection?

The driver is the one who is ultimately responsible for ensuring that the vehicle assigned to them is in safe operating condition. The driver is the one who has highest amount of exposure with the vehicle and, would have a good idea of conditions and issues with it.

When should this be done?

Before the vehicle is taken out, the driver should review the previous Post Trip report and go over it closely in the event there were any issues with the vehicle when it was returned. Once the previous vehicle inspection has been reviewed, the driver does an inspection of his/her own to highlight any discrepancies from the previous report. Supervisors or Managers should be informed of these discrepancies or any safety concerns.



Benefits of a Pre and Post Trip Inspections

Properly carried out Pre-Trip and Post Trip Inspections can help control costs and help keep drivers safe while operating vehicles on the road.

Benefits include:

- Uncovering unsafe conditions with the vehicle before they

cause accidents

- Catch mechanical problems before they cause a costly breakdown or accident
- Avoid any infraction that may lead to a fine or citation
- Improving the knowledge of drivers on how to spot conditions or hazards with work vehicles, how to document them, and report them correctly so they can be addressed properly

- In the event of a crash Inspection Reports may be reviewed as part of the accident investigation process. Inspection Reports serve as a written record of notification between the driver and their supervisor regarding the condition of the vehicle, and when the conditions reported were addressed.

And if that's not enough...
